A. Call to the Public

B. Public Comment on Agenda Items

C. Approval of Meeting Minutes

- Minutes from the March 18 meeting were approved unanimously.

D. Budget Report – Finance Department

Summary of expenditures as of April 2026:

- Youth: \$436,842 spent; \$262,430 available

- Adult: \$325,738 spent; \$11,577 available
- Dislocated Worker: \$156,307 spent; \$45,829 available
- Administration: \$77,815 spent; \$25,380 available
- Rapid Response: \$96,761 spent; \$8,884 available

Additional Notes:

- County staff has made major improvements in spending down expiring funds.
- Clarification provided regarding Program Year vs Fiscal Year funding structures.

E. WestEd Workforce Strategic Plan Presentation

Presenter: John Brauer, Workforce Project Director

Highlights:

- Multi-month stakeholder engagement across county regions.
- Development of labor market analysis, industry gap analysis, and workforce resource mapping.
- Key issues raised by stakeholders: youth outmigration, lack of aligned systems, housing shortages, childcare needs, and transportation barriers.
- High interest in apprenticeships, CTE, healthcare careers, tourism, and cross-border logistics.

F. Bylaws & Attendance Compliance

- Updated bylaws approved by Board of Supervisors.
- Board emphasized seriousness of attendance requirements to maintain voting quorum.
- Two members identified as non-compliant: Luis Padilla and Pedro Sete.
- Staff instructed to prepare recommendations for Board of Supervisors regarding membership changes.

G. One-Stop Operator Report

- Statewide job fairs remain active and well-attended.
- No WARN notices for Santa Cruz County.
- Attendance challenges exist among Santa Cruz partner agencies.

H. Executive Director Report – Zaida Bustamante

- Preparing new MOU and IFA for July 2027–June 2029.
- Local Plan Modifications due October 30, 2026.
- Promoting Arizona Workforce Summit attendance.

- Expecting 120+ job seekers at upcoming seafood processor hiring event.

I. Title I Program Report

- Significant outreach to schools, fairs, and community events.
- Multiple youth in work experience placements, including Gym Click, PBS Auto, and Nogales FD.
- Increasing push for certifications via Pima College and Job Corps.

J. Apprenticeship Discussion – Major Employer Input

Local employer **Roy Bustamante (HVAC)** raised important concerns:

- Students often lack hands-on experience despite certifications.
- Trades require real-world conditions (heat, heavy labor, field-based problem solving).
- Local small businesses want to train youth but need structured support.
- Strong plea for more local apprenticeships and better alignment with real employer needs.

Board & Staff Response

- Agreement that apprenticeships are underdeveloped in Santa Cruz County.
- State Apprenticeship Office will contact Mr. Bustamante to begin setting up a formal apprenticeship program.
- Desire to support small businesses *at the same level* energy is given to big employers like South32.
- Recognition that many youth prefer hands-on career paths over traditional 4-year college routes.
- Process exists—needs more push, communication, outreach, and employer engagement.

K. Title II, Title III, Title IV, NFJP Reports

- Title II submitted written report.
- Title III not present.
- Title IV (VR) has staffing transitions but continuing services.
- NFJP currently serving 4 participants; increasing outreach in rural areas.
